## ULTIMATE CAMPING NETWORK (ULTIMATE)

**MEMBERSHIP TERMS AND CONDITIONS.** The agreement signed by a purchaser subscribing to ULTIMATE is a separate and distinct contract from the purchaser's agreement with the seller of a local resort membership. ULTIMATE is not a real estate offering, nor is there any ownership between ULTIMATE and any of its affiliated resorts. ULTIMATE does not have any direct interest in developing, selling, or managing any membership resort participating in the

ULTIMATE Network. All ULTIMATE use privileges are subject to availability at the individual ULTIMATE Affiliate Resorts. ULTIMATE usage may not be used in conjunction with or in addition to other affiliation programs in order to extend overnight stays, or allow re-entry into the ULTIMATE System in a manner other than allowed under ULTIMATE's Membership Benefits and Guidelines. Member usage is subject to space availability. *There are no pre-assignment of or exclusive rights over specific campsites or distribution among Members of usage periods. ULTIMATE does require Resorts to contribute campsite inventory to ULTIMATE's Central Reservation System.* To manage services properly, reservations may be required for overnight camping. Participation in the reciprocal program is conditioned on compliance with the terms and conditions of the Affiliation by the member.

**ULTIMATE PLUS AND ULTIMATE MEMBERSHIP PRIVILEGES.** ULTIMATE PLUS and ULTIMATE membership benefits are set forth in the Membership Benefits and Guidelines and incorporated herein by reference as if set out verbatim on this page. ULTIMATE may adopt, revise, add to, amend or repeal various membership benefits as it deems appropriate in its reasonable discretion. Nightly fees are subject to change at the discretion of ULTIMATE and surcharges may apply at certain resorts. Membership Benefits and Guidelines may be found online at [www.UltimateCampingNetwork.com](http://www.UltimateCampingNetwork.com). Following any overnight stay of three (3) or more nights, ULTIMATE members must remain out of the ULTIMATE system a minimum of seven (7) days before resuming camping overnight in the ULTIMATE system. Separate reciprocal programs may not be used to provide for back-to-back visits at the same resort. ULTIMATE PLUS membership includes Condominium Travel Club Platinum (CTC Platinum) privileges (see below).

**RESTRICTIONS.** Membership privileges through ULTIMATE are non-transferable. Member is limited to (3) overnight visits per year at ULTIMATE Affiliate Resorts within 100 miles of Member's residence. ULTIMATE members must cancel their reservations twenty-four (24) hours prior to arrival or be charged a \$20.00 no-show fee.

**RULES SUPPORTING MEMBER SATISFACTION.** Membership use privileges are subject to Member's observance of rules established by ULTIMATE and Resort to ensure enjoyment of all Members in their use of Resort and the ULTIMATE System, which rules are hereby incorporated. Resort and/or ULTIMATE may adopt, amend or repeal such rules, provided that any such change does not materially reduce use privileges for the majority of Members.

**RESORT MANAGEMENT COMMITMENT TO MEMBER.** The individual ULTIMATE Affiliate Resorts retain all management responsibility and authority to carry out the management role. This shall include, but not be limited to: the maintenance of Resort campground facilities in a manner that allows Member the reasonable use and enjoyment of the Membership; the payment of all property taxes, insurance, utilities and other ordinary and necessary expenses of Resort operations. ULTIMATE resorts may be open to the public. Some resorts may have blackout days when only home-park members are allowed. ULTIMATE privileges are provided through Resort maintaining its licensing agreement with ULTIMATE. Eligibility for continued and/or renewed ULTIMATE Membership is subject to Resort maintaining its licensing agreement and its affiliation with ULTIMATE. Member is required to pay all fees charged by ULTIMATE and individual Resort for their usage and to use these programs subject to the separate rules established by ULTIMATE and participation Resorts. There is no assurance this licensing agreement will remain in effect. ULTIMATE shall not be held liable for Resort's failure to maintain its licensing agreement.

**ULTIMATE ENROLLMENT FEE & ANNUAL DUES.** ULTIMATE Affiliated Resorts arrange for payment of member's initial ULTIMATE enrollment fee. In subsequent periods, member will be billed directly for their ULTIMATE membership. The amount of annual ULTIMATE dues and paid-through-date of initial ULTIMATE annual dues is outlined on the face of this Agreement. Subsequent dues will be billed in advance. Dues are subject to increase. Annual dues notice will also include optional membership charges for qualified AFM's. Membership renewals more than 90 days delinquent may result in termination of ULTIMATE privileges, and are subject to a reinstatement fee of \$150.00. Member's continued participation in ULTIMATE is dependent upon payment of annual dues. ULTIMATE reserves the right to increase dues or fees for use of the program, including nightly fees. Any increase will be based upon an amount deemed reasonable by industry standards.

**WARRANTY LIMITATIONS.** There are no warranties which extend beyond the description on the face hereof including, without limitation, implied warranties of merchantability of fitness for a particular purpose. The Membership is based on the use of ULTIMATE Affiliate Resorts as they presently exist, and in no way reflects additional value for any amenities planned in the future. ULTIMATE is not a provider of accommodations and is not responsible for the physical condition, or any aspect of its affiliated resorts, or for any statements made by any agent of its affiliated resorts at the time a Membership is purchased or afterwards. ULTIMATE is not responsible for any personal or property damage resulting from the acts, omissions or negligence of any affiliated resort or any other matters that affect or inconvenience the Member. ULTIMATE's liability to Member, in all respects, is limited to the amount of annual dues for any fiscal year.

**STARLITE CAMPING NETWORK (SLN).** The SLN network is a network of public RV parks and campgrounds made available to ULTIMATE Members at a discounted nightly rate. Any action by Member to challenge or enforce these terms and conditions or that of any of the programs within the ULTIMATE Membership must be submitted exclusively to the jurisdiction of the courts of Gunnison County, Colorado, and by maintaining Membership with ULTIMATE, each Member consents to the personal jurisdiction of these courts.
