I have personally inspected my home resort, and understand that my contract with my home resort is separate and apart from ROD Plus, CTC Blue and NACC, and ROD Plus, CTC Blue and NACC have no obligations under that contract.

TERMS AND CONDITIONS OF MEMBERSHIP

1. **RESORTS OF DISTINCTION; HOME RESORT.** To be a member of Resorts of Distinction Plus Program, you must be a member in good standing with Resorts of Distinction and you must be an upgraded member at a Resorts of Distinction Plus Program affiliated resort (your "Home Resort"). Additional amenities related to the use of your Home Resort, not use of the Resorts of Distinction Plus Program, must be the primary reason you purchased your Home Resort upgraded membership. This agreement between you and Resorts of Distinction is separate and distinct from the agreement between you and your Home Resort. Resorts of Distinction does not own your Home Resort or any other Resorts of Distinction Plus Program affiliated resort. If the contractual affiliation between your Home Resort and Resorts of Distinction is not renewed, or is terminated for any reason, you may no longer participate in the Resorts of Distinction Plus Program or any other Resorts of Distinction program.

2. **RESORTS OF DISTINCTION PROGRAM.** Resorts of Distinction Plus membership entitles you to participate in the Resorts of Distinction reciprocal program (the "ROD Plus Program"), which allows use of facilities and amenities at all Resorts of Distinction Plus affiliated resorts. ("ROD Plus Resorts"). Your participation in the Resorts of Distinction Plus Program is subject to the terms and conditions and the rules and procedures set forth herein and set forth in the Resorts of Distinction directory and/or other Resorts of Distinction publications (the "Rules"). You acknowledge that you have read and familiarized yourself with this agreement and the Rules before signing this agreement, and that the Rules are made a part of this agreement. The Rules in new Resorts of Distinction directories supersede all prior publications. The terms and conditions of this agreement and the Rules can be revised, modified or added to, in Resorts of Distinction's sole discretion, if Resorts of Distinction believes such changes would be beneficial to the Resorts of Distinction Plus program. Your membership in Resorts of Distinction is for 90 days, with no obligation to renew for subsequent years. You may terminate your membership at any time upon written notice sent by U.S. Mail to Resorts of Distinction, effective the first full month following Resorts of Distinction's receipt of such notice. However, there is no rebate or proration of membership fees.

3. **RESORT QUALITY.** All ROD Plus Resorts are independently owned and operated. Resorts of Distinction cannot guarantee that any particular ROD Plus Resort will continue to remain affiliated with Resorts of Distinction or its ROD Plus Program. Resorts of Distinction makes no representations or guarantees regarding the quality of any ROD Plus Resort. Resorts of Distinction directory information is provided by the ROD Plus Resorts and Resorts of Distinction believes all the information it contains is complete and accurate, but Resorts of Distinction is not responsible for errors or inaccuracies.

4. **AVAILABILITY.** As more fully set forth in the Rules, use of ROD Plus Resorts is subject to space availability and Resorts of Distinction cannot guarantee that your request or reservation to use a particular ROD Plus Resort at any particular time will be fulfilled. The availability of sites at smaller and new ROD Plus Resorts is especially limited. Space availability during more popular times and/or in more popular areas of the country is also limited. Resorts of Distinction shall not be liable for any problems arising from accommodations at, or inability to use, any ROD Plus Resort, or any other matters that affect or inconvenience your use of an ROD Plus Resort or your vacation.

5. **NON-RESPONSIBILITY.** Resorts of Distinction is not a provider of accommodations and is not responsible for the physical or financial condition, or any aspect of, any ROD Plus Resort (or affiliated services/programs or offers from other third parties made available through Resorts of Distinction) or for any statements made by any agent of any ROD Plus Resort at the time a membership is purchased or afterwards. Any representations concerning the Resorts of Distinction Plus Program are limited to written materials supplied or otherwise approved by Resorts of Distinction. Any other representations are not valid or binding upon Resorts of Distinction. Resorts of Distinction is not responsible for any personal or property damage resulting from acts, omissions or negligence of any ROD Plus Resort or its employees or agents. The relationship between Resorts of Distinction and ROD Plus Resorts is strictly governed by the affiliation agreement, and any addenda or amendments thereto, between Resorts of Distinction and the ROD Plus Resort, and Resorts of Distinction is not responsible for the ROD Plus Resorts, their operations or their arrangements or agreements with you. Complaints or claims regarding any ROD Plus Resort shall be between you and the ROD Plus Resort. Resorts of Distinction's liability to you, in any and all circumstances, is limited to the amount you paid to Resorts of Distinction for your annual fee, if any, for ROD Plus membership in the year such liability arose.

6. **ANNUAL FEE:** You are required to pay Resorts of Distinction an annual fee, at the then current rate, if you wish to be a Resorts of Distinction Plus member and participate in the Resorts of Distinction Plus Program. You can select a camping option when renewing your Resorts of Distinction Plus membership, either: 1) "Free Camping" or 2) "Pay as you Go". The Free Camping renewal option allows you to camp for FREE (meaning that site night fees are not charged) at the affiliated resorts, or you can choose to pay for the site night fees by selecting the "Pay as you Go" renewal option. Once you have selected your renewal option, it cannot be changed until the next renewal date. Any member who allows their Resorts of Distinction Plus membership to lapse for more than 90 days will be required to pay a reinstatement fee of \$300.00 in addition to the then current annual fee. If your Resorts of Distinction membership expires you will not be eligible to renew the free camping option.

7. **GOVERNING LAW.** This agreement, and any dispute between you and Resorts of Distinction, shall be governed by the laws of the state of New York without regard to its conflicts of law principles. Venue for any action at law or in equity shall be in Monroe County, New York. In the event you sue Resorts of Distinction for any reason and do not prevail, Resorts of Distinction shall be entitled to recover its attorney's fees and litigation expenses from you.

8. **TRANSFERABILITY.** Your Resorts of Distinction Plus Program membership is not transferable.

9. **NATURE OF MEMBERSHIP.** Your Resorts of Distinction Plus membership and right to use ROD Plus Resorts is solely for your recreation and enjoyment. Your Resorts of Distinction ROD Plus membership is neither sold nor purchased as a financial investment, and you receive no interest in the contract rights, assets, or business of Resorts of Distinction. Resorts of Distinction does not purport to sell, lease or otherwise devise or convey any interest in any real property. You may own only one Resorts of Distinction Plus membership.

10. **HEADINGS.** The headings in this agreement are for everyone's convenience, and are not to be used to interpret this agreement.

11. **TRAVEL ACCOUNT.** To travel in the Resorts of Distinction system you must activate your Travel Account by purchasing Travel Credits (as of 1/1/011, Travel Credits can be purchased for one dollar each). Travel Credits will be used for site night reservations, rental units, ancillary products, site night fees, etc. In order to travel in the ROD system, you must have a balance of at least 25 Travel Credits. Anytime while the membership is active, or within one year after termination/expiration of your membership, you may request a refund of your Travel Account balance by sending a written request to: Resorts of Distinction, Travel Account Manager, P.O. Box 100, Valentines, Virginia 23887. A \$5 administration fee will be imposed. Any Travel Credits remaining in the travel account one year after termination/expiration of the membership are not refundable.

By signing this membership application I request a membership into CTC BLUE. I understand there are yearly membership dues payable to remain a member.
